Sadly, the Democrats might miss the opportunity to protect the last semblance of American Democracy. ## **CREW** report

Georgia recently enacted legislation to give Georgia counties more power to cheat In this report, CREW identifies 35 rogue election officials across the country who have already refused to certify election results and may be in a position to do so again. The report focuses on the eight states where county officials have unlawfully refused to certify elections since 2020: Arizona, Colorado, Georgia, Nevada, New Mexico, North Carolina, Pennsylvania and Michigan. The report also identifies the legal remedies available to state and federal authorities, as well as voters, to protect the certification of the 2024 election.

"Republican-controlled Georgia election board passes rule that may delay vote certification (Reuters) –

Georgia's Republican-controlled state election board approved a new rule on Monday that voting rights advocates say could permit local election officials to delay certification of November's presidential election results, potentially throwing the outcome of the battleground state's vote into uncertainty.

The five-member board, which includes three members championed by Republican presidential candidate Donald Trump, voted 3-2 to empower county election board members to investigate any discrepancies, even minor ones, between the number of cast ballots and the number of voters in each precinct before certification.

Such mismatches are not uncommon and are not typically evidence of fraud, according to voting rights advocates, who say the rule could permit individual board members to intentionally delay approval of the results.

Trump, who praised the majority's three members by name during a Georgia campaign rally earlier this month, has falsely claimed for years that the 2020 election was rigged by fraud.

His infamous January 2021 phone call in which he asked the state's top election official, Republican Secretary of State Brad Raffensperger, to "find" enough votes to sway the outcome helped lead to Trump's pending indictment on state charges."

Writ of mandamus

In most states, the primary mechanism to force an official to certify an election is a civil lawsuit seeking a writ of mandamus, which asks the court to compel a government official to perform their legal duties. While the precise requirements for mandamus differ from state to state, as a general matter, a party seeking a writ of mandamus must satisfy three elements:

1) it must be clear from state law that the official has a non-discretionary and ministerial duty;

2) mandamus must be the only adequate remedy for the situation;

and 3) the person or entity bringing the lawsuit must have a clear legal right to the action requested.

These requirements will generally be easy to satisfy when certification has been withheld — and, indeed, successful mandamus

## Federal

The ballot includes one or more federal candidates The crime involves an election official abusing his duties The crime pertains to fraudulent voter registration Voters are not U.S. citizens

What is not a federal election crime?

Giving voters a ride to the polls

Offering voters a stamp to mail an absentee ballot

Giving voters time off to vote

Violating state campaign finance laws

Distributing inaccurate campaign literature

Campaigning too close to the polls

Trying to convince an opponent to withdraw from a race

Federal election crimes fall into three broad categories—campaign finance crimes, voter/ballot fraud, and civil rights violations.

Campaign finance

A person gives more than \$4,600 to a federal candidate (various limits apply for donations to and from committees and groups)

A donor asks a friend to give money to a federal candidate, promising to reimburse the friend, and the friend makes the donation and the real donor reimburses him

A corporation gives corporate money to a federal candidate

A person who is neither a citizen nor a green card holder gives money to a federal, state, or local candidate

Civil rights violations

Someone threatens a voter with physical or economic harm unless the voter casts his ballot in a particular way

Someone tries to prevent qualified voters from getting to the polls in a federal election A scheme exists to prevent minorities from voting

## Voter/ballot fraud

A voter intentionally gives false information when registering to vote

A voter receives money or something of value in exchange for voting in a federal election or registering to vote

Someone votes more than once in a federal election

An election official corrupts his or her office to benefit a candidate or party (e.g., lets unqualified voters cast ballots)
